

# **ArtsVote in Connecticut**



(Updated as of 8/20/24)

#### Ensure Your Vote is COUNTED on Election Day, Tuesday, Nov. 5, 2024

## **CONFIRM:** Pre-Requisites

- Be a U.S. Citizen
- Be a resident of Connecticut
- Be at least 18 years of age by Election Day, Tuesday, November 5, 2024
- Not be currently confined in a federal or state prison for a felony conviction

# **STEP 1:** Register to Vote & Check Accuracy

Check the Accuracy of your <u>current voter registration</u> or **Register to Vote** for the first time <u>online</u>, by <u>mail</u>, or <u>in-person</u> by **Friday, October 18, 2024**. If registering **online** or by **mail**, your registration must be RECEIVED or POSTMARKED by your local <u>Registrar of Voters</u> by **Friday, October 18, 2024**. If you miss this deadline, then you must register in-person either at your <u>early voting location</u> or at a designated <u>Same Day Registration location</u> on Election Day. <u>Don't delay, pledge to check the accuracy of your voter status or register to vote by Friday, September 27, 2024.</u>

## **STEP 2: Request Your Absentee Ballot (If Needed)**

Connecticut will only allow voters to vote by <u>Absentee Ballot</u> with an **excuse** that meets one of the approved <u>specific</u> <u>requirements</u>. Applications for Absentee Ballots can be <u>completed online</u> or you can mail a <u>downloaded</u> application. For the General Election in November, the online portal **opens** on **August 7**, **2024**. You can also pick up an application at the office of your local <u>Town Clerk</u>. A request can be made at any time; however, you must allow enough time for the Town Clerk to processes the application and send the absentee ballot. Submit your application **as soon as possible** as ballots become available 31 days prior to the election. Track to see if your Absentee Ballot is received through your <u>Voter Registration Lookup</u>. **Don't delay, pledge to complete your Absentee Ballot application by Tuesday, October 15, 2024**.

### **STEP 3: Cast Your Vote**

ABSENTEE BALLOT: If you requested an Absentee Ballot, you can cast your vote in several ways. If returning your Absentee Ballot by mail to your <u>Town Clerk</u> or to a ballot box of the municipality, it must be RECEIVED by Election Day, Tuesday, November 5, 2024 by 8:00pm. If hand-delivering your ballot, it must be RECEIVED by your <u>Town Clerk</u> by Monday, November 4, 2024. Don't delay, pledge to return your Absentee Ballot by Tuesday, October 29, 2024.

– OR –

IN-PERSON VOTING: Cast your vote early in-person at an early voting location from Monday, October 21, 2024 to Sunday, November 3, 2024 between 10:00am and 6:00pm. Extended Voting is also available on October 29, 2024 and October 31, 2024 from 8:00 am - 8:00 pm. If you choose to vote IN-PERSON on Election Day, Tuesday, November 5, 2024, polling hours take place between 6:00am until 8:00pm at your assigned polling place. Your ID is not required to vote, but does help facilitate the process. Please view a list of acceptable voter ID. Don't delay, pledge to cast your vote to have your say!

### **STEP 4: Celebrate Your Vote**

**Celebrate** being an ArtsVote leader by posting a selfie of you mailing-in your ballot or wearing an "I Voted" sticker on social media.
